A motion made by Ms. Bentley and seconded by Ms. Egan to approve the Agenda as presented. Ayes: All. Motion carried.

A motion made by Mr. Brookins and seconded by Ms. Danforth to approve the minutes for the January 3, 2017 Regular Rose City Council Meeting. Ayes: All. Motion carried.
